I'm writing as outside counsel on behalf of Liberty Mutual Insurance Company. Following an internal audit, we realized that contributions from the Liberty Mutual Insurance Company PAC had been misreported on the Company's in-house lobbyist's reports rather than on separate C-5 reports for some time. In an effort to correct the mistake, we are submitting the appropriate C-5 Out-of-State Political Committee reports, along with the accompanying amended Lobbyist Monthly Expense Reports and Employer's Lobbying Expense reports for the affected time periods.
